# Director's Message



Dear Friends:

Another six months have passed by and I am happy to report that these six months have been extremely fulfilling, both in terms of personal achievements and in the affairs of the Institute. XISS has the rare privilege of being honored with the "Sir J.R.D. Tata Chair Professorship" for an initial period of 3 years. Dr. Anirudh Prasad has

been appointed as the Chair Professor because of his inspiring contribution to the fields of corporate social service and rural development initiatives. In terms of academic initiatives, XISS has not lagged behind. Prof. S.N. Singh of IM Department, was awarded the Doctoral Degree for his thesis on Combinatorial Problems by University of Ranchi. Three other faculties have either submitted their doctoral thesis or are on the verge of submitting them. The faculty members contributed 24 papers in the national and international journals and conferences. The Department of Research & Planning has broken new grounds by bagging research and consultancy projects worth Rs. 14.5 Million in the past six months.

Another development is that the Xavier Institute of Polytechnic (XIPT) will start functioning shortly at Bargawan, Namkom. Initially it will offer three diploma courses in Electrical and Electronics, Mechanical and Communication Engineering.

As regards to the global connections of XISS, I participated in the 16th Conference of International Association of Jesuits Business School held from 18-20 July at Ateneo De Manila University, Philippines. The theme of the conference was "Educating Champions of Sustainable Development: The Best Practices of our Business Schools". About 100 delegates were present from 16 Jesuits Business schools from USA, Europe, Asia, Australia and Latin America. I presented a paper entitled "Educating Champions of Sustainable Development: Best Practices of XISS in Rural Development".

Followed by this was the Asia's B-School Award Program at Suntec Hotel in Singapore on 23rd of July 2010. On behalf of XISS, I received the Innovative Leadership Award. We feel proud that XISS has been recognized internationally. I also established contacts for networking with other B-Schools and agencies for International Accreditation. We will pursue the matter in the coming months.

I take this opportunity to thank all Faculty members, Project officers and Staff for their support and reiterate my commitment to achieve greater heights in academics, out-reach programs and placements.

## 49th Annual Convocation—2010

The 49th Annual Convocation of Xavier Institute of Social Service (XISS), Ranchi took place on the 30th of March, 2010. This was the first convocation which was undertaken under the leadership of Fr. Alex Ekka sj who was appointed the Director of XISS in September last year. The Chief Secretary of Jharkhand, Shri Shiv Basant was the chief guest for the occasion.

The convocation started on a somber note, as the august gathering observed two minutes of silence in memory of the two founder Directors of XISS who passed away last year - Fr. Michael Albert Windey sj, the founder Director of XISS on 29th of September, 2009 at Heverlee, Belgium and Fr. Michael Van Den Bogaert sj, the 2nd and it's longest serving Director, on 31st of August, 2009 at Raipur, Chattisgarh.

Fr. Ranjit Toppo sj, Provincial of the Jesuits Society, Ranchi and Chairman of the Governing body of XISS delivered the welcome address. He urged the graduating students to work for the growth and development of the people. He extolled the students to remain true to their roots and to focus on health, education and poverty alleviation.

Speaking at the convocation, Shri Basant said that Government policies were partly responsible for multinationals attracting the best managerial brains; creating a dearth of professionals to carry out agricultural and rural development schemes. He urged the State and the Central Governments to implement a policy that would attract the best managers to the agricultural and rural development sector. He said that growth and development would remain an utopia until and unless the policy of financial inclusion was aggressively followed at the level of the panchayats. Financial inclusion was necessary for 30-40 percent of the Indian population. He further assured the students that there was no dearth of jobs for them. Sending out a clear message to the young and budding managers, he said "You should not be afraid to take risks. Why become an employee, when you have the potential to become an

entrepreneur?"

Fr. Alex Ekka sj, Director, presented the annual report of the Institute. In the annual report, he highlighted the achievements of XISS in the last academic year and thanked the faculty and the staff for their untiring zeal and devotion to the Institute. He welcomed the new faculty members and staff to the Institute—Major Indrajit Banerjee who joined the Department of Marketing and Mr. Md. Ashraf and Mr. Anuj Kumar Verma on the staff of Finance and Accounts. He congratulated Prof. S.N. Singh for being awarded the doctoral degree in mathematics from Ranchi University. He also congratulated Dr. Anirudh Prasad, Professor of Rural Development and HoD, Research and Publications, for being honoured with "Chair Professor" of Sir JRD Tata Chair, for his outstanding contribution to Corporate Social Services and Rural Development initiative and management.

He informed the gathering that the placements were better as compared to other times during the recession period. He expressed his hope that some of the students who could not secure a job on-campus would find jobs very soon. Keeping the focus on entrepreneurship and vocational training, he said that three new courses in electrical, electronics and telecommunication would be started very soon at the Xavier Institute of Polytechnic and Technology (XIPT) at Bargawan Namkom. He concluded his address by saying that XISS will strive to achieve greater heights in academics, outreach program and placements. The Chief Guest awarded the Diploma and Medals to 330 Graduating Students of the Institute.

# **Departmental News**

### Department of Rural Development

In February, students of Rural Development were sent to remote villages along with supervisors for rural camps. Sahoo and Mr. Ashok Kumar, (c) Tigra village (Ratu block) under Dr. M.H. Ansari and Mr. Ajit Tirki, (d) Sorha village (Namkum block) under Dr. H. Sinha and Dr. M. Sahu, (e) Chatti village (Fudi-Khunti block) under Mr. Prakash Kumar and Mr. Sant Prasad and (d) Dorma village (Khunti block) under Dr. K.K. Bhagat and Mr. A. Ahmad.

Educational tours for the final year students were organized in December 2009. Students were exposed to different development organisation in different parts of India.

### Department of Marketing & Finance

#### Department of Personnel Management

The department had good final placements with 24 students getting placed in 10 companies. The salary package ranged from Rs. 6.75 lakhs to Rs. 2.75 Lakhs with an average offer of Rs. 4.4 Lakhs per annum. There were two pre-placement offers from Tata Steel and Atos Origin offered international placements. Companies that came in to campus were Vedanta, Tata Steel, Jindal Steel, Siesta Hospitality, HCL, Hero Honda, GVK and Dhanalakshmi Bank.

#### Department of Information Management

The department, in collaboration with Reliance Communication Ltd., organized a seminar on "Network Security". The well known security expert Mr. Ankit Fadia was the main speaker and he deliberated on the various aspects of network security.

Due to Global Recession, the placement scenario was not up to the mark as only 6 students secured on campus jobs. The department is actively engaged in exploring employment avenues with a number of organizations.

Ms. Samina Zareen, a student of 2009-11 batch, presented a





technical paper on "Geoinformatics Initiatives for Agricultural Development" at a national seminar on Engineering and Environment held at Cochi in October 2009. Ms. Shiwangi Prasad, a student of 2008-10 batch, received the prestigious "Sir Ratan Tata Scholarship" for the year 2009-10. The participation of the students continued in Panache-2010 with many students of the department securing prizes in Business Plan Competition, Song and Dance Events, Rangoli and Face Painting.

#### Department of Research & Planning

The department bagged seven new projects and renewed one ongoing project. These projects will earn a record-breaking revenue of Rs. 1.45 crores for the Institute.

The department is currently engaged in the following projects: (a) R&R related Social Impact Assessment for GVK Company Ltd headed by Dr. PK Panda and Mr. A. Ahmed (b) Preparation of Rehabilitation Action Plan for Raniganj Coal Field Area in West Bengal headed by Mr. Ahmed and Mr. Pratul Chandra. The project will cover 33-35 thousands households in Raniganj and Asansol Areas in West Bengal (c) DISE project of Sarva Siksha Abhiyan in all the 24 districts of Jharkhand was led by Mr. W. Norman, Mr. A. Dey and Mr. H. Ekka. (d) Monitoring of SSA progress in the districts of Jharkhand by Mr. A. Tirkey and Mr. A. Biatha at the behest of MHRD, Govt. of India. The work has been highly appreciated by the Ministry. (e) Impact Evaluation of NTPC Korba's CSR Activities led by Mr. S. R. Irfan and Mr. H. Ekka has been completed in May 2010.

Dr. Himadri Sinha completed the evaluation study of National Innovative Agriculture Program with the support of Mr. P. Chandra and Mr. S.R. Irfan. He also completed the Strategy Plan for Oxfam India's intervention in Jharkhand in association with Mr. W. Norman and Mr. A. Dey.

Tirkey and Sunil Tigga attended All India Diakonia Partners Meet at Hotel Shakti International, Puri, from 11th—13th May 2010.

#### Development Resource Center (DRC)

DRC is implementing a Community Leadership Program (CLP) since July 2010 with support from JTT, Mumbai in Jharkhand and Bihar. The program aims at developing leaders at community level, enhance their leadership competencies to assist them in empowering the community, and also contribute towards NRHM goals. The implementing organizations are NBJK (Jharkhand) and IDF (Bihar).

During the period, NBJK and IDF, completed the process of nomination and identification of 800 panchayat leaders. 19 block level conventions were organized by the partners in their respective areas. Different stakeholders were invited in these conventions that focused on "NRHM and role of leadership" towards building an environment for program implementation.

DRC conducted CLP Master Trainer's training program on 2-7th Feb 2010 and 15-23rd Mar 2010 respectively for project personnel. Mr. Sant Kumar, Mr. Bhaskar Chakravorty and Mr. Dheeraj Horo coordinated the entire program. DRC has printed the Project Brochure and given to partner NGOs for wide circulation. It is developing a training module. Posters on 4 thematic areas (Infant care, Pregnancy, Safe Delivery and Nutrition) have been developed and draft copies sent to NBJK and IDF for field testing.

Field support visits have been conducted by Program Officers and Accountant to NBJK and IDF for accounts and programmatic monitoring and support.
