From the Editor's Pen.....

e are very pleased to present to you AXIS 2020 which is the Annual of our Institute. It contains the Director's Report and the departmental reports written by the respective department heads for the academic session 2019-20. The Reports contain an account of the prominent activities that have taken place in the current academic session and also the roadmap for future action wherever possible. AXIS is released every year during the Convocation ceremony of the Institute. Due to corona virus pandemic and subsequent nation-wide lockdown, the Institute was unable to hold its annual convocation on 8th April as decided earlier. The publication of AXIS therefore got delayed to June 2020.

Our Institute has been in the forefront of creating a sustainable society and nation building through a bouquet of high quality education, research and social outreach programs since 1955.

The Institute imparts education by strictly adhering to six core Jesuit Values. They are:

- 1. Magis: Meaning "more." This is the challenge to strive for excellence.
- 2. Women & Men for and with others: Sharing gifts, pursuing justice, and having concern for the poor and marginalized.
- 3. Cura Personalis: "Care for the individual person," Respecting each person as a child of God and all of God's creations.
- 4. Unity of Heart, Mind, & Soul: Developing the whole person and integrating all aspects of our lives.
- 5. Ad Majorem Dei Gloriam (AMDG): For the Greater Glory of God.
- 6. Forming & Educating Agents of Change: Teaching behaviors that reflect critical thoughts and responsible actions on moral and ethical issues.

By following these cardinal principles of Jesuit education, the Institute has produced professionals who are serving our great nation in various capacities and making a difference to the lives of thousands of people.













A number of new initiatives have been taken in recent months to improve our business processes and quality to bring it in line with the way modern education is imparted. Details of the same can be accessed in the Director's Report.

The contemporary India is a tough place to be in, especially because of the economic crisis that is slowly unfolding due to the devastating effects of corona virus pandemic. After clocking 4.5% growth in Q2 FY20, which was lowest in the last 25 quarters, the Indian economy grew by a very moderate 4.7% in Q3 FY20. The NSO's estimates revealed that the fourth-quarter and fiscal 2019-20 growth slumped to 3.1% and 4.2%, respectively, the slowest pace in 11 years. The unemployment rate of 6.1% in FY2018 for which the latest official data is available is the highest in 45 years. Inflation is over the upper limit of the inflation target regime of 6%. The coronavirus pandemic has plunged the Indian economy into recessionary conditions. Domestic rating agency Crisil has cut its GDP forecast for India to 1.8 per cent for 2020-21 while projecting total losses of Rs 10 lakh crore or Rs 7,000 per person due to disastrous lockdowns to control COVID-19 pandemic. This is likely to make the job scenario even more challenging. Management schools, including ours, will have to think out of the box to beat recession and find appropriate solutions for the emerging crisis-like situation.

In recent years, the technical education regulators, the AICTE and its arm NBA, have taken a number of initiatives to improve quality of management education. The most significant of them is a move to make learning outcome-based and more in line with industry requirements. This involves three distinct steps. First is to set educational objectives, then fix an appropriate learning methodology and finally identify indicators that measure the extent to which the objectives have been achieved.

We, at XISS, have tried to bring our course curriculum in line with the regulators' recommendations. Last year, the various PGDM Programs constituted Board of Studies, comprising eminent academicians, business professionals and decorated alumni. The Boards recommended a broader, more business-aligned, a more outcome-based and more than fully AICTE-compliant course curriculum which was approved by the Academic Council of XISS. We hope that this initiative will bring about significant improvement in the way we impart learning and make professionals more competent to face today's economic and social challenges.

Governance and Academic Restructuring:

As the Acting Director of the Institute I have taken up and completed various assignments, details of which will follow.

NBA accreditation: A long-felt need for the accreditation process was started and took an aggressive mode when a dedicated person was appointed for the task. Ms Aayurshi has a 7 year-long experience in the same field with some esteemed institutions in East India. With our diligent efforts and the accreditation team's guidance, we will strive to get the NBA accreditation completed by the end of 2022. Ms Shruti Sahay has been appointed as Assistant Officer for Media and Accreditation for XISS.

For better co-ordination with the Alumni Association of XISS (AAXISS), Prof. Nidhi Shukla has been made the faculty co-ordinator for Alumni Relationship. Similarly, Dr Rik Das is the in-charge and SPOC for SWAYAM implementation, Dr Amit Giri for promoting research and publications, Dr Anant Kumar to look after the International Relations and Prof (Dr) Shyamal Gomes as the head of Research and Publications and promotion and publication of JJDMS.

There was a need for the Central Data Bank and Data Analytics which has also been taken into consideration and a team has been assigned for the work. Fr. Francis David Kullu, SJ, along with Mr. Anugrah Kujur and Mr Pankaj Tirkey are working in this team.

Institute has taken various new initiatives during this time under the present leadership like the implementation of ERP solution, online courses for students and faculty members from SWAYAM platform, focus on research and publications, steps towards branding and accreditation of the Institute, online payments for fees, students' official email-id, digital adoption in academics and administration, implementation of NAD (National Academic Depository) for XISS students etc.



2. Reports of various Academic Programs

A. Human Resource Management

The main highlight of the academic session 2019-20 was the introduction of a fully restructured and redesigned Course Curricula for the PGDM program in Human Resource Management. The newly designed program, in line with the AICTE guidelines, was duly approved by the newly constituted Board of Studies for HRM program. Due to increased credits carried by the program, the number of classes increased significantly, and the academic workload of students has gone up substantially. However, this is likely to produce more thoroughbred professionals.

With 72 as the total strength of the batch, the students have been very successful in the placement season with 57 students placed as of date. The highest CTC was given by Flipkart; Rs 26.49 lakhs p.a; and the average pay package was Rs 8.61 Lakhs p.a.

The Industrial Camps, Rural Retreat and Rural Exposure including the Social Service Field Work, the Industrial Visits are some co-curricular activities which were carried on with great vigour and enthusiasm. The active participation of students and faculty members have given innumerable stances of learning and development.

Several Industry-Academia Interface programs like guest lectures, alumni interaction and talks from reputed industrialists helped the students to become market-ready in terms of training and professionalism.

A new initiative of tutorial classes began where two second-year students of HRM were appointed as Student Tutors and they helped first-year students in subjects like Social Research Methodology, Financial Accounting, MS Excel, Operation Management etc.

In a nutshell, the program under the guidance of Prof. (Dr.) Ramakant Agrawal is striving to reach greater heights of quality and excellence so that success automatically follows.

B. Rural Management

The Rural Management program is one of the reputed programs of XISS. The program is the oldest program of its kind in India. However, the challenge before us today is to make it the best program of its kind offered by any Indian B-school and in the changing context. To pursue our goal, the course curriculum has been revised comprehensively to blend our core objectives of *'Putting the last first'* with the updated knowledge, technical skill and professional competency progressively. The revised curriculum is designed to incorporate norms set by national and international accreditation bodies. The international credit system has been introduced so that students can get the benefit of the credit transfer across the world universities. Compulsory audit courses (non-credit) like Yoga for health and Indian constitution have been incorporated to orient our students more holistically. SWAYAM courses have been introduced so that students can pursue add on courses to enhance their competency and make them future ready.

The students raised their bars in this year's placement season where organisations have recruited 69 students which is 94.52% of the strength of the current batch.

The curricular and co-curricular activities of the program like rural camps, industrial visits etc helped students to carve a niche for themselves in being able to match classroom learning with the practicality in the market.



RM students have made the program and broadly the Institute proud by participating and winning various extracurricular events like sports, inter-college music competitions, debates, paper presentations etc.

Growing along with others has always been a motto of the Rural Management program in XISS and under the guidance of Prof. (Dr) Himadri Sinha, we have done well to live up to this motive of ours.

C. Information Technology

Information Technology (IT) has become a vital and integral part of every business plan. From multinational corporations who maintain mainframe systems and databases to small businesses that own a single computer, IT plays a significant role. It is also the foundation of contemporary disruptive trends with Artificial Intelligence (AI) and Business Analytics. Application of Information Technology in all verticals of business functions is imperative for value addition to incessantly changing customer expectations.

The placement season for the academic year 2019-20 was extremely good for the IT program which witnessed 83.33% placement as of now. Constant improvement in the course structure and up-gradation of the infrastructure along with constant training and development programs for the faculty and students makes this program not only unique but with cutting edge advantages.

Emphasis on tutorial classes and MOOCs from SWAYAM also played a lead role in the betterment of this program.

The experience of Dr Mahua Banerjee and her untiring efforts to outplay the IT program has contributed to the betterment of the program and as one of the best in the zone.

D. Marketing

The program of Marketing completed yet another academic year of 2019-2020 with great success.

This year the program experienced some significant developments in all the aspects of curricular, co-curricular and extracurricular activities. The program of Marketing Management achieved 89.09% placements.

Up-gradation of the syllabus with the consent of the Board of Studies to make the program structure more market-friendly was the need of the hour and under the guidance of Dr Pinaki Ghosh, this was done extremely aptly.

Alumni Interaction, visits to Industries, sensitizing students to grassroots level problems through rural exposure were all activities done to bring out the hidden business acumen in the students and increase their employability in the tough market situations.

E. Finance

Like every year XISS welcomed its new batch 2019-21 with the freshers' orientation program on June 19th 2019 with utmost zeal and zest. The most unique feature of this program is that it gives equal emphasis to the rural exposure of the students in the management education followed by the industrial visits, soft-skills development and other activities which contributes to the 360-degree development of the students.



The academic year 2019-20 brought another good placement season for the program where the students earned a remarkable feat of placing 96.43% students which were achieved through methodical training and well-designed sessions on mock interviews and mock GDs. The department channelized and focused its resources under the capable guidance of faculty members to help students acquire the skills important for the industry. Various programs like mentorship and deliberation on key events impacting economy/financial markets helped them shape their understanding and vision about the key concept concerning the markets.

Numerous initiatives for the development of faculty and students under the encouraging leadership of Dr Arup Mukherjee makes the program able enough to meet the market needs running parallel with the socially responsible curriculum.

F. The Central Placement Cell

The placement cell of XISS is proud and elated to announce that the placement season 2019-20 has been truly remarkable and a landmark event. The feat we have achieved would not have been possible without the unwavering trust the corporate has shown in the quality and competitiveness of our students despite a generic slowdown in the overall employment scenario. It is a huge encouragement and humbling event and makes our resolve to serve the corporate with a supply of capable and energetic talent stronger.

The final placement figures this year has already touched **88.59%** and with few more numbers of companies still lined up for the process, we are set to soar higher still. As a testimony of competence and tenacity our students exhibited during their internship period we received **11 PPOS**. Highest CTC we clocked was another feather in the cap of the Institute. Two students from PGDM-HRM received CTC of Rs **26.49 lacs**; highest ever. Stipend offered to summer interns was equally encouraging with the highest stipend of Rs **1.25lac**. The Department of Finance Management, Department of Rural Management, the Department of Marketing and the Department of IT have achieved placement of **96.43%**, **94.52%**, **89.09% and 83.33%** respectively. Congratulations and thanks to the all team members of Central Placement Cell and also the coordinators from different programs.

The Institute has shown immense flexibility and agility amidst a fast-changing job environment. Future job seekers are not only going to be judged for showing their ability to perform in a challenging environment but also how they adapt to fresh challenges that may come their way. Therefore, it is advised to all candidates for the upcoming placement season 2020-21 to brace for a tough year.

G. Department of Research and Planning

After its establishment in the year 1978, the Department of Research and Planning has created a distinct space for itself within and outside the Institute through continuous engagement in different academic activities and carrying out several consultancy research projects.

During the academic year 2019-20, the department completed as many as 8 research projects in various districts of Bihar, Jharkhand, Haryana, Chhattisgarh and Odisha. Two ongoing projects near to completion are also the task at hand for the department which under the privileged guidance of Dr. Pramil Panda strives to create a niche for itself.



In the financial year 2019-20, the project liaison cell has applied 16 projects, out of which there are 4 projects related to social impact evaluation of activities done under corporate social responsibility, 4 projects related to the evaluation of programs undertaken by the governments, 3 projects related to baseline studies, 3 projects related to end-line studies and 1 each of the projects related to socio-economic survey and sanitation survey respectively. Besides, there are also 5 GIS projects applied in the financial year 2019-20.

H. Department of Research and Publications

The Department of Research and Publication of XISS was established in June 2002. The overall objective of the department is threefold: (i) to conduct research studies independently, (ii) to select quality research articles and publish those in academic journal JJDMS, and (iii) teaching, organizing seminars, talks and workshops. Since its establishment, the Department is continuously striving to move ahead in terms of its research growth and publications.

JJDMS got indexed in the ICI database. On 1st May 2019, Indian Citation Index released the approved list of the new journals and JJDMS included in their new list.

In the year 2019, so far, the following thematic/non-thematic issues have been published:

- 1. General Issue (January-March 2019)
- 2. Governance and Management of Natural Resources (April-June 2019)
- 3. General Issue (July-September 2019)
- 4. Health and Wellness (October-December 2019)

I. Library and Documentation

The involvement of Information and Communication Technology (ICT) in libraries makes the possibility of easy access to information in many formats and from many sources cause encouragement, progress learning capabilities, reading habits as well as knowledge among users.

Presently our Institute library has varieties of collection in print and digital forms including books, journals, magazines, newspapers, CDs, DVDs, online resources like e-books, journals, magazines and business cases etc. All these resources give the value addition in teaching, learning and research.

The library has fully computerized the routine work as well as library services through ERP. Now resources as well as services like check-in, check out, book renewal, fine collection, web OPAC, generation of statistical reports etc. are available at your fingertips within campus as well as outside campus using internet.

Our Institute has subscribed to 48 peer-reviewed national and international print journals. Out of 48, 22 **SAGE print journals** are also available online on a complimentary basis. Besides, our library also subscribes to 25 magazines and 13 newspapers.

Our Institute's library has 3275 back volumes of bound journals.

Orientation events are organized by library patrons regularly to make the students and faculty well versed with the technological advancements and the online resources in the library.



J. Department of Entrepreneurship Development

Entrepreneurship Development Cell in XISS has emphasized the following:

- To organize all types of Entrepreneurship Development Programs (EDPs).
- Capacity building for SHG members.
- Small Industries Management Program (SIMAP) and & short term Management Development Programs (MDPs) for different target groups.
- Research and Publication in the field of Entrepreneurship.
- Organizing Faculty Development Programs (FDPs) and Trainer's Training Programs (TTPs).
- Provide consultancy services to existing entrepreneurs for their further development, expansion.
- Organize Awareness Camps, Seminars, Workshops, Trainer's meet, etc.
- Working as a resource unit for other EDP related Institutions.
- Conduct Skill Development Training programs for groups.
- Assist Small & Medium Enterprises (SMEs) by organizing customized training programs for their Human Resource Development, or by providing specific consultancy.

During the academic year 2019-20, there were 5 programs with a cumulative of 466 participants held at various Entrepreneurship Awareness Camps in and around Ranchi and one Faculty Development program with 23 participants in the XISS, Ranchi campus. The number of proposed programs for the next academic year sums to 11, for faculty, young entrepreneurs and aspiring youth.

K. Development Resource Centre:

DRC, as its name suggests is a Resource Centre and has been playing a crucial part since its inception by supporting various developmental initiatives undertaken by small NGOs and CBOs across Jharkhand. DRC under the aegis of Xavier Institute of Social Service (XISS) has been following the mission of serving the society and thus has been implementing several projects for improving the lives of villagers.

During the year 2019-20, DRC completed the project Enhancement of Livelihood Opportunities in the selected blocks of the south-eastern region of Chotanagpur in the state of Jharkhand.

DRC, XISS, Ranchi has submitted a **"Proposal on Watershed Development"** to National Bank for Agriculture and Rural Development (NABARD), Regional Branch, Ranchi. The operational area will be in Murhu Block of district Khunti in Jharkhand.

L. Childline Ranchi

Childline Ranchi has been functioning since 2001 under the ministry of women and child development Government of India. XISS a nodal agency for Childline Ranchi facilitated the rescue of lost, missing, runaway or victimized children and their rehabilitation. Childline stands for a friendly Didi or Bhaiya who is always there for vulnerable children 24 hours of the day 365 days of the year. During the period April 2019 till February 2020 Childline Ranchi has intervened a total number of 129 cases of child protection issues which includes cases like child

labour, child marriage, sexual abuse, physical and emotional abuse, child trafficking, corporal punishment, beggary, etc. Childline Ranchi as intervened total number of 497 cases till date including all categories.

3. Achievement and Awards

The Institute has been put at 20th position in all India B-School ranking by Business and Management Chronicle survey 2020 ranking the third position in top 10 Institutes in terms of international collaboration and ranking, 10th in the top 10 Institutes in terms of social responsibility for the year 2019-20. NHRDN -Shine Business School has ranked XISS at 6th position among the Institutes in Eastern India and 36th position among top 50 B schools of the country for the year 18-19. In 2019 XISS has actively participated in different B schools always such as BT-MDRA B School survey 2019, Times Annual B School rankings 2020, The Week B School survey 2019, Business and Management chronicle B school survey 2020, NHRDN-SHINE Business School survey 2019-20, NIRF ranking 2019-20 by the MHRD, Government of India to name a few.

4. XISS in the National and International Market

5. The Road Map Ahead

With the current turn of events, we are facing a national lockdown due to the pandemic of Covid-19. I have always seen a silver lining in dark clouds and this lockdown has forced me to realize the importance of virtual learning. In the coming days, the Institute is willing to upgrade its IT infrastructure to use an online platform for bringing efficiency in administrative as well as academic works. The talks, seminar, online courses etc. needs to be done through a virtual platform.

The very first action plan for XISS in the coming days is to finish the NBA documentation comprehensively and aptly so that the Institute can complete the process as soon as possible and obtain the required accreditation within due time.



The second plan of action is rolling out of all the policies of the Institute with the revised students manual and faculty manual for the smooth and streamlined functioning of the organisation.

Understanding that alumni as one of the strongest pillars of an Institute I would like to strengthen the bond between the alumni and their alma mater with regular homecomings, alumni meetings and their involvement in crucial academic, projects and industry affairs. The Institute is planning to make AAXISS (Alumni Association of XISS) more structured and process-driven involving the different chapters with online platform for smooth and regular operations and interactions. Updated Alumni database creation is also a priority.

With the adoption of the ERP system, we are already into the process of outcome-based learning. With technological advancement, this system will help not only internally but also in revamping the brand image of the Institute externally. Brand building is hence another very important task at hand.

HUMAN RESOURCE MANAGEMENT

INTRODUCTION:

he new Academic Session 2019-20 started on June 17th, 2019. It was inaugurated by Shri Rajesh Sharma, Secretary, Higher Education, Government of Iharkhand. Dr Prof Shailendra Kumar, Director, IIM Ranchi, was the Guest of Honour on the occassion. This was followed by a 5-day Induction Programme for the new batch of HRM students. Once the induction was over, the normal classes began in full swing. For the first time, the induction programme involved talk by a qualified medical practitioner, Dr A K Thakur from



Medanta Ranchi, on student's mental and physical wellness.

The main highlight of the academic session 2019-20 was the introduction of a fully restructured and redesigned Course Curricula for the PGDM program in Human Resource Management. The newly designed program, in line with the AICTE guidelines, was duly approved by the newly constituted Board of Studies for HRM program. Due to increased credits carried by the program, the number of classes increased significantly and the academic workload of students has gone up substantially. However this is likely to produce more thoroughbred professionals.

The Institute acquired membership of the professional body National HRD Network (NHRDN) in January 2020. National HRD Network is committed to the development of human resources through

education, training, research and experience sharing. It works towards enhancing the capability of human resource professionals to compete globally.

Last year, we became members of the Confederation of Indian Industry. We are in the process of acquiring membership of more professional bodies to improve our capabilities.

The Department has undertaken a number of activities during the Academic Session 2018-19, a brief description of which follows.

STUDENT ACTIVITIES & ACHIEVEMENTS : CURRICULAR, CO-CURRICULAR & EXTRA-CURRICULAR

Industrial Camp

An industrial camp was organized for the class of 2019-21 from 27th Feb 2020 till 7th March 2020. Two groups of 37 students of the HRM batch of 2019-21 under the guidance and leadership of Prof Dr K M Spring went for their Industrial Camp. They visited various organizations where they interacted with the HR domain experts and gained invaluable inputs in addition to their theoretical knowledge. The organizations they visited were; CCL – Barka Sayal, Tata Motors, Waxpol, CCL – HRD – Darbhanga House, Hindalco-Muri, Tata SteeL – Jamshedpur, Jindal Steel- Patratu. Their visit consisted of plant visits, along with corporate interactions. They also got an opportunity to be part of the celebrations of Tata Workers Union – Jamshedpur, where they attended a conclave on 'Trade Unions of the Future'.

Rural Retreat

Rural Retreat (RR) is an integral part of the HRM program. First year students were on rural retreat from 27th-February to 06th-March. As part of this exercise, they stayed at Society for Rural Industrialization (SRI), Bariatu and worked in its operational village Jiddu (Amber toil, Jamun Toli and Jiddu Khastoli) at Angara block of Ranchi under the guidance of Prof. Dr. Shyamal Gomes. Rural retreat is an important activity to work towards our Vision and Mission of serving the society which has given us so much. The RR activity helps HR students to appreciate the challenges of life faced by people especially in the rural areas and to learn from them how to overcome such problems on a daily basis. During the course of the RR, students learn crucial management skills like leadership, teamwork, need identification and time management. They are also asked to learn and practice meditation techniques to improve their concentration and mental strength. Moreover, the village visits and interacts with people, Government Officials and NGO workers helped the HR students to understand the ground reality of Rural India.

This year, students specifically interacted with 8 Women Self-Help Groups in Jiddu Revenue Village. Rural Retreat helped them to learn 3 important aspects: 1) Role of W-SHGs in the context of Rural Governance and Rural Human Resource Development, 2) Importance of Integrated farming and how rural technology is enhancing the lives of rural men & women as rural entrepreneurs in the field of fisheries, goateries, piggeries, dukeries and floriculture, horticulture and vegetable cultivation etc. and 3) How the PRIs and block development officials are taking initiatives for health, hygiene, income generation and other aspects of human development.



Students also interacted with Mukhia of Jona Panchayet, Mr. Krishna Munda and Pramukh of Angara Block, Mrs. Sunita Gari to understand the government schemes and the present context of Rural Governance. Through 'Shramdan' and Nukkad Natak in different Tollahs the HR students spread awareness about cleanliness, health & hygiene and respect to elders.

Social Service Field Work (SSFW)

Social Service implies social welfare and socio-economic development as well as politico-cultural empowerment particularly of the deprived sections of society. So, exposure of the students to the social reality of the country is part and parcel of management education in the Institute. The SSFW is a fundamental component of the PGDM-HR program. The SSFW is the central mechanism for transmitting theoretical knowledge into the practical level of work. First year students of the HRM program are sent to different non-profit and humanitarian

organizations in and around Ranchi twice a week where students get the opportunities to apply knowledge learnt in the classroom situation.

In the current Academic Session, students were placed in seven Field Work Centers: St. Michael School for Blind, Braj Kishore Netraheen Balika Vidyalaya, MMK High School, Cheshire Home, Guru Nanak Home, St. Xavier's School, Doranda (outreach) and Government Middle School, Hindpiri.

They contribute to the overall efforts of the social service being done by the organization. The students implement and evaluate their experiences while working with individuals and groups in their field work situation. Through active involvement in SSFW, students are encouraged to generate new insights into the problems faced by the inmates. Our students' contributions range

from imparting academic support, helping the underprivileged children to realize their potential and hold different kinds of functions. The events organised by our students include Independence Day, Republic Day, Annual Sports Day, Cricket Blood Donation Tournament, Camp, Origami and craft and card making sessions, Diwali and Holi celebrations, Medical and Health Camp, Extempore competition among the inmates and Home visits of the underprivileged children. The students also conduct inter-center visits to learn from exposure to different other organizations.

Groups of 4 students made pre-placement presentations in 25 companies including Emani Cement, Berger HUL, Linde, Tega Industries, Himadri Chemicals, TATA Sky, FlipKart, Gainwell, Khadims, RBL Bank, AXIS Bank, HDFC Bank, L&T, RailTel, Mission of Mercy Hospital and Research Centre, TCS, Reliance Jio and Positive Strokes. The

entire students also made plant visits to 7 companies which included Tata Steel, EXIDE Haldia Plant, Hindustan Unilever (Haldia Detergent Factory), and TIL Limited (Kharagpur), Tata Metaliks (Kharagpur) and ITC Food division (Uluberia) and ITC Kidderpore Plant.

During their factory visits they interacted with the Practicing Managers, Senior Managers- HR, and the Trade Union leaders to understand the current business management strategies as well as Human Resource Practices in the Corporate / Organizations. While taking the feedback from the company



it has been observed that most of organizations have positive feelings and confidence towards XISS alumni performance especially in the HR field and expressed hope that the current crop of students will do well in their profession.

PLACEMENTS

Summer Placement

Thirty seven companies have offered Summer Internship to 75 students. The average stipend offered is Rs 16000, with highest stipend offered being 120000. The companies range from Flipkat, Nomura, Tata Steel and Tata Motors to Reliance Industries, IOC, Metlife, ITC, Vedanta and Taj Bangalore. Due to nationwide lockdown, 62 students have been asked by their respective companies to work from home and the remaining 13 have been put on hold.

Final Placement

The Placement of the HRM batch of 2018-20, went off to a flying start, with 17 companies visiting the campus for the first phase of placements, (25th October – 05th December 2019), namely-- Hindalco Industries Ltd, Godrej & Boyce, Tata Steel Ltd, Tata Steel BSL Ltd, Indian Hotels Company Ltd, Vedanta, SBI Life, Flipkart, Tata Motors Ltd, Jindal Stainless Ltd, Hero MotoCorp, Darwinbox Digital Solutions Pvt Ltd, Nuvoco Vistas Corp Ltd, Hindustan Unilever Ltd., Reliance Industries Ltd, ICICI Bank, CISCO Systems (India) Pvt Ltd, ACC Ltd, Bandhan Bank. The second phase of placements, (6th January - 31st March 2020) also, saw a healthy turnout of organizations for recruiting HR candidates from XISS. The companies were, Volvo Eicher Commercial Vehicle, Basix Sub K iTransactions Ltd, Tech Mahindra, Saija Finance Pvt Ltd, Tata Advanced Systems Ltd, Fincare Small Finance Bank, Cadila Pharmaceuticals Ltd, Aarti Industries Ltd, Forsys Software India Pvt Ltd, MBAtrek Pvt Ltd, and ABFRL (Pantaloons).

In addition to the above 4 PPO's were also offered to the students of the HRM dept of XISS. The highest CTC was given by Flipkart; Rs 20.46 lakhs p.a; and the average pay package was Rs 8.40 Lakhs p.a. 57 students have been placed so far.

MOOC/Swayam

Certificate Course in SWAYAM: Swayam is a program initiated by Government of India and designed to achieve three cardinal principles of Education Policy i.e. access, equity and quality. This is done through a platform that facilitates hosting of all the courses, taught in classrooms from Class 9 till post-graduation to be accessed by anyone, anywhere at any time. All the students of HRM program registered themselves in different certificate courses offered in SWAYAM platform. All professors of the HRM program are serving as a mentor of at least two courses opted by the students. Universities/ colleges approving credit transfer for these courses can use the marks/certificate obtained in these courses for the same.

Student tutorial:

A novel initiative was started by Dr Amar E Tigga, Acting Director, this academic year to help students cope with difficult subjects. The initiative was called Student Tutorial. Under this scheme, a student from second year taught students of first year who needed additional guidance. Two second year students of HRM were appointed as Student Tutors and they helped first year students in subjects like Social Research Methodology and Financial Accounting.

CONCLUDING REMARKS:

The current academic year 2019-20 has been a landmark year for the Institute. A number of very significant and remarkable changes have taken place. To start with, Dr Prof Amar E Tigga took over as Acting Director from Dr Fr Alex Ekka SJ, who served the Institute for 12 long years with distinction and single-minded devotion. R ural Management program is one of the flagship programs of XISS. The program is the oldest program of its kind in India. However, the challenge before us today is to make it as the best program of its kind offered by any Indian B-schools. To pursue our goal, the course curriculum has been revised comprehensively to blend our core objectives of 'Putting the last first' with the updated knowledge, technical skill and professional competency progressively. The revised curriculum is designed to incorporate norms set by national and international accreditation bodies. The

international credit system has been introduced so that students can get the benefit of the credit transfer across the world universities. Compulsory audit courses (non-credit) like Yoga for health and Indian constitution have been incorporated to orient our students in a more holistic manner. SWAYAM courses have been introduced so that students can pursue add on courses to enhance their competency and make them FUTURE READY.

The academic year began with administrative changes. Fr. Dr. Alexius Ekka S.J bid adieu to XISS after serving XISS as Director for the past 10 years. Dr. Amar Eron Tigga has been appointed as Acting Director. We offer our heartfelt thanks and gratitude to our current Acting Director Dr. Amar E. Tigga

and Assistant Director Fr. Pradeep Kerketta, S. J. for their visionary and dynamic leadership and benevolent support to the RM program.

Progress Towards Accreditation

Introduction of Revised Course Curriculum: The PGDM-RM course curriculum has been thoroughly revised during 2018-19 to incorporate the specification given in AICTE guidelines and also meet the expectation of NBA. The revised course curriculum was studied by the members of Board of Studies (BoS) and it was approved by BoS in its meeting held on April 26, 2019. The revised course curriculum was introduced with effect from 2019-21 batches. The salient features of the revised course curriculum are (a) Introduction of credit based curriculum so that students can take the benefit of inter university credit transfer; (b) choice based electives for 42 credits; (c) two compulsory audit courses on Yoga and Indian constitution; (d) Offering SSWAYAM courses to students for doing add on courses through MHRD portal free of cost; (e) Two Comprehensive Grand Viva Voce at the end 1st and 2nd year so that students can be examined on holistically and to prepare them for UPSC style interviews, and (f) Weekly guest lecture series by inviting eminent scholars, development practitioners, senior bureaucrats. With these changes now PGDM-RM course curriculum is now ready for NBA accreditation.

Student Activities: Curricular, Co-curricular & Extra-Curricular

Institutional Visits (IV): The purpose of institutional visits is to provide focused exposures pertaining to major developmental issues. First year students were divided into two groups for this purpose. The objective of the first visit was to orient the students with the development of agriculture and allied activities. One group visited Krishi Vigyan Kendra (KVK) Divyan, Ranchi and another group visited KVK, Hazaribagh. The visit took place on 26th July 2019 under the supervision of Dr. Sant Kumar Prasad and Dr. N. Sahoo respectively.

The second IV was held on 27th September 2019 at three field centres of JSLPS. The purpose of the visit was to learn from JSLPS's field interventions. The visits were supervised by Dr. K. K. Bhagat, Dr. R. S. Verma & Mr. Sanjay Verma.

Urban Field Exposures (UFE): First year students of Rural Management have undergone Thematic Field Work in different groups in ten slum centres of Ranchi town. This work is now being done in collaboration with World Vision of India. Students devoted their afternoon session for two hours with the slum community to understand socio-economic conditions, rapport building through group activities, mobilizing community members, understand their feeling and knowledge, develop an attitudinal and behavioural change, understand sociological aspects of the community, literacy, health and social well-being. Students facilitated the local community towards health and sanitation, child rights and teaching hygienic practices (Table 1). The UFE was coordinated by Mr. Sanjay Verma.

Rural Camps: Altogether twelve rural camps were held as a part of rural exposures for developing rural understanding and gaining practical insights for rural development. Six camps three each for first and second year were held during 15th to 24th October 2019 and similarly six more camps were held during 27th February to 7th March 2020. The detailed objectives of the camps are given in Table 2. On November 13, 14 & 16, 2019, both first year and second year students presented their findings

before the department. These presentations enhanced their understanding of rural realities. Inter camp exchanges also found to be mutually beneficial for all students. The camps were supervised by Dr. H. Sinha, Dr. K.K. Bhagat, Dr. Sant Kumar Prasad, Dr. Anant, Dr. N. Sahoo, Dr. R.S. Verma, Dr. P.K. Panda, Dr. A. Singh, Mr. S. Verma, Mr. A. Dey, Mr. Aditya Raj, & Mr. Harshvardhan. Jahanabad Camp Group (RM-2) has prepared a comprehensive report named AAGAAZ (New Beginning) to be released during Convocation 2020.

Study Tour: Study tour provides ample exposure to the students to be acquainted with various types of organisations spread across our country and various development interventions they are engaged in. This year students were divided into three groups viz. North, West and South. North group consisting 25 students under the supervision of Dr N. Sahoo visited 13 organisations in two states –Himachal Pradesh and Delhi and two UT Jammu & Kashmir & Chandigarh. They also had had an alumni meet in Delhi. The West group comprising 25 students under the supervision of Mr. Sanjay Vermavisited eleven (11) organisations in Maharashtra. Likewise South group consisting of 23 students under the supervision of Dr. Sant Kumar Prasadvisited nine (9) organisations in three states viz. Andhra Pradesh, Karnataka & Tamil Nadu.

Agriculture Field Practical: Agriculture Field Practical (AFP) took place during Mid-September to November 2018. Dr. H. Sinha conducted eight practical visits including visit of IINRG (Formerly Indian Lac Research Organization) and Horticulture research centre Eastern Region at Palandu. Remaining practical classes were conducted at Agriculture Training Centre, Namkom. These practices were based on agriculture production and Lac cultivation. The duration of the practical was 35 hours.

Dr. Alok Pandey conducted practical on Livestock production and dairy processing. The duration of these practicals was 6 hours. Students visited Animal Farm of BAU and Medha Dairy plants.

RM students have performed outstandingly both in co-curricular and extra-curricular activities. In sports and games, our students have put up splendid performances in Interclass Basketball and Badminton, and inter university/ B-school Basketball tournaments.

- 1. In the interclass Basketball tournament, RM Girls with their splendid performance defeated HRM girls in a thrilling final to become the XISS champion for the first time during the past ten years. Megha Kujur was awarded player of the tournament. Ms. Ankita, Ms. Divya Kujur, Ms. Puja, Ms. Pragya Toppo and Ms. Prachi played pivotal role in winning the tournament.
- 2. In the Boys section, the final was all RM affairs. No other class team could match the skill and brilliance of RM 1 and RM 2 teams. In the final RM 1 won the trophy by defeating their seniors in the most exciting match. Akash Glad Minj from RM-I was adjudged as the player of the tournament.



3. The XISS Chess team under the leadership of Mr. Atul Kumar Sinha of RM final year has won the inter-collegiate Chess Tournament organised by IIM, Ranchi. This is the first team XISS has ever won such a tournament.

Besides the above, students of Rural Management program (batches 2018-20 and 2019-2021) have been very active in all cultural activities held on-campus or off-campus during the year 2019-20.

- a. On-campus XISS: The events include the first as 'MILAP' which was organized on 16th July 2019 in order to welcome the new batch that is 2019-21. On 24th August 2019 'CSR CONCLAVE' and on 8th-9th November 2019 National Conference on 'Voices of Un-heard, Putting the Last First' was organized, in collaboration with 'Save the Children' and "Plan India". In these events, students had shown their cultural glimpse through the cultural night. There were several other events where our students excelled. Megha and Rishabh were runners up in the singles Badminton tournament held at XISS in the month of January 2020.
- Off-Campus participation: There were several off-campus events where our students have b. showcased their talents at various levels. On SWATCHTA PAKHWADA a skit competition organized by CCL was a platform where the students presented a skit in the month of June 2019. Another major event was on 30-31 July 2019 in Kolkata where Conclave was organized by U.S. Consultant on the topic 'International Youth Campaign, Anti-trafficking in person', where 6 students participated. On 28th September 2019 Rai University had organised "GOONJ" in which students participated in the painting competition. Next was 'VAJRA' organized by BIT Mesra on 8-10, November 2019, where our students stood first in the basketball tournament. 'VALHALLA' organized by XLRI was another opportunity for our students to show their talent, one of the students of Rural Management program was runner up in poetry competition and street play. Another event was SAMVAAD organized by TATA Steel on 15th and 16th November 2019 where our students participated. Inter College summer internship report presentation competition named INTERNICO'19, held at BIT Mesra. Ms.Pushpanjali from RM 2018-20 batch participated and qualified in the top 8 and presented her report there. On Independence Day cup which was organised by XLRI Jamshedpur, RM boys and girls team participated in different games like Chess, Football and Basketball. Again on 8-9 February 2020, students participated in SIGMA-XLRI, Social Entrepreneurship Conclave, with a theme on Women Changemaker in the Social sector. The chess tournament was organised by IIM, Ranchi on 1-2 February 2020 as Rush 5.0 in which the XISS team was the winner. This team had students from the RM program. Similarly, Team XISS participated in IMT Ghaziabad, a Sports meet in which they won the gold medal. In this team of 8 members, 5 are from the RM program.
- c. Student's Club of RM: PRAKRITI: The Student's Club of Rural Management program 'PRAKRITI' is governed and regulated by the students of the Rural Management program. The team was officially launched on 24th August 2019 during the CSR Conclave organized by Rural Management program and handled by Team Prakriti. This was the first event of Team PRAKRITI which was conducted and appreciated on a public platform. But the team started functioning way before the launch. On 25th July 2019, a talk on CSR and R&R was organized which was delivered by Dr. S.K. Panda, IAS. On 26th July 2019. Naman Kumar, Aman Kr Verma, Saurabh Kumar Jaiswal and Ankit Sinha are the founding members of this Rural Management Students Club. The



second talk organized by PRAKRITI was on 1st August 2019 by Shri Rastogi, IFS, Chairman, Jharkhand Pollution Control Board who delivered a lecture on Sustainability and Development. This was soon followed by a talk on 8th August 2019 by Dr. Madhuri Sharma from US University who enlightened us on the topic of Income Inequality. Soon after the launch, Team PRAKRITI in collaboration with Save the Children organized a one day program on 29th August 2019, on the theme "The Right Start". On 8th and 9th November 2019, a

National Conference was organized on "Voices of The Unheard: Putting the Last First" which was officially covered by Team Prakriti. On 1st February 2020, Shakti Vahini, an NGO working on human trafficking in collaboration with the US Consulate, Kolkata organised an event in XISS with Ms. Marie Royce, Assistant Secretary, Bureau of Educationist and Cultural Affairs, US Department of State. The focus was on empowering adolescent girls for community leadership to combat human trafficking and gender-based violence.

Students' Picnic

After long years of gap, RM program organised a fun filled picnic for students and all members of RM program on 11th January 2020. The picnic was held at Bagmunda falls near Basia in Gumla district. Nearly all students participated in it. Students and faculty had a great time unwinding themselves from their daily schedule and getting rejuvenated. Assistant Director Fr. Pradeep Kerketta, S.J., also visited the picnic and boosted the morale of everyone.

PLACEMENTS

Summer Placements

For the summer of 2020, PGDM-RM students were originally placed in 21 organizations for their SIP (refer Table-4). However, due to Covid-19, the students could not do organizational training (OT) in earlier assigned organizations. As per AICTE directives students were allowed to do OT through virtual online arrangements. Under this arrangement all 72 students completed their OT by 5th June 2020.

41 students did their virtual OT in Development Connects, 9 students in TSRDS, Jamshedpur, 6 in Jharkhand State Food Commission(JFSC), 5 students in People Science Institute (PSI)- Dehradun, 3 students in Taru Foundation, Korba, and 2 students each in IIIT – Bengaluru, Jaljeevika –Pune, Devkamal Hospital- Ranchi and Tata Chemical Society of Rural Development (TCSRD).

Final Placements:

The Rural Management program assisted the students of rural management to get jobs in different organisations/companies. The current final year batch had 73 students. As on 12th March 2020, 22 organisations have recruited 69 students which is 94.52% of the strength of the current batch. However, the number wise RM program recorded the highest number of placements. Some more organisations are expected to participate in placement programs before 30th June 2020. Dr. Sant Kumar Prasad is currently co-ordinating the placement with the help of three student representatives viz. Mr. Avinash, Ms. Pushpanjali and Mr. Uday Shankar.




Fig. 1: Sector wise students' placement

Sector wise analysis shows that 41.2% students are placed in Livelihood Mission programs followed by NGOs (19.1%), Banking sector (16.2%), CSR (8.8%), Skill development (7.4%) and Micro-finance (7.4%)(Fig.1 & Table 6).

Placement of Students (in % age)

COLLABORATIONS & CONNECTIONS

1. Research Collaborations

- i ESRC Research: ESRC (Economic and Social Research Council) of the United Kingdom has approved a joint research project of Warwick University of UK and Xavier Institute of Social Service (XISS). The project title is 'Identification of factors affecting successful outcomes in the DDU-GKY Indian skills program for unemployed young'. The project is of 20 months duration from April 2019 to November 2020. Dr. Clare Lyonette of Warwick University and Dr. Himadri Sinha are the joint principal investigators of the project. Mr. Avinash Anand has been appointed as program Manager for the project. One national workshop and three training programs were conducted during April and May 2019. The project area includes DDUGKY project running under BRLPS1¹ (in Bihar) and JSPLS2² (in Jharkhand). Till February 2020 all baseline surveys have been completed in Bihar and Jharkhand. The project will facilitate wide scale academic exchange between XISS and Warwick University.
- **ii. Research:** Sustainability of sanitation change in low- and middle-income countries: The project was financed by the Czech Science Foundation (Project GA19-10396S). For the project, Dr. Josef Novotný and Dr. Anant Kumar serve as the contact persons at the Czech and Indian side, respectively. The data collection is complete and analysis and writing are in process.
- **iii. Institutional Collaboration with Charles University:** MoU was signed with Charles University, Prague, the Czech Republic for five years on 29th July 2019. An MoU was signed between XISS and University of Charles for five years w.e.f. 9 July 2019 to collaborate and establish a research and scholarly working relationship. Based on principles of equity and reciprocity, this MoU will serve as a general framework for co-operation between the Participants and is intended to facilitate discussions for more specific programs of collaboration.

- i. Fulbright Student Supervision: Fulbright-Nehru grant recipient joined XISS for Research Project in January 2020. Ms. Juliet Flam-Ross, a graduate in BA Economics from Oberlin College, Ohio (US) is a Fulbright-Nehru grant recipient from USIEF (United States-India Educational Foundation). She has joined Xavier Institute of Social Service (XISS), Ranchi and will be working on her research project, "Human Development Implications of Substance Abuse in India". Juliet has visited India a couple of times in the past. When asked, why did she choose XISS, she stated that she got to know about Dr. Anant Kumar through his research work (Dr. Kumar is a Nehru-Fulbright Scholar and an Associate Professor in the program of Rural Management, XISS) and through his colleagues in Delhi and that she preferred the method of research being carried out at XISS under the mentorship of Dr. Kumar, as he uses a combination of qualitative and quantitative research techniques, that is also her preferred way for conducting research.
- **ii. Students Exchange program with Belgian University:** Ms. Ankita Choudhury, Ms. Jaya EtiMinj and Mr. Pawan Kumar Bharti of Rural Management Department (Batch 2019-2021) will participate in the summer course 'Europe: Diversity and Migration' (29 June 10 July 2020) at Stadscampus, University of Antwerp, Belgium. The course focus is on Europe related diversity and migration issues, based on a mixture of theoretical, practical and empirical insights from an interdisciplinary perspective to provide insights, information, and tools based on empirical case studies and several field visits. The summer course is funded by the USOS scholarship, covering travel, accommodation and subsistence allowance to attend the course. Ms. Ankita Choudhury and Mr. Pawan Kumar Bharti will participate in the course on USOS scholarship and, Ms. Jaya EtiMinj will participate as a self-sponsored candidate.

Guest Lectures Series: Industry/ Developmental Professionals/ Academicians Interface:

As a part of the knowledge enhancement, thirteen guest lectures had been organized during the academic year 2019-2020. The total duration of guest lecture series was 22.45 hours. During 18-19 only five such lectures were arranged. These lectures had helped the students improve their learning on a wide variety of topics. CSR Conclave on Role of CSR in Small Business Development for Rural Sector

After the enactment of the new Company Act 2013, various companies have taken positive measures towards socially inclusive business development and empowerment of poor stakeholders. Development of small business for poor and vulnerable sections has yielded constructive results across the country. Such initiatives have brought economic empowerment of poor and marginalized and also ushered a new era of social uplift and initiation of eco-friendly joint ventures. Owing to this significance of small business in the rural sector, this one-day CSR conclave was organized by Dr. Sant Kumar Prasad and Dr. Niranjan Sahoo, Associate Professors of XISS on 24th August 2019. This conclave had a primary focus on the CSR roles in development of small business for the rural sector. What is the future of the RM profession? Despite phenomenal economic growth, India is lagging behind in the Human Development Index. In the recent HDI report 2019, India ranked 129 which is behind our south Asian neighbors Bangladesh, Sri Lanka, Bhutan, and Nepal in HDI ranking. India remains the home of 364 million poor people (28 percent), out of a global population of 1.3 billion. While government funding for rural development is shrinking, the challenge of RM profession is increasing till India attains HDI ranking among top 20 in the world. Therefore, scope of RM profession is likely to be widened and demand for RM professional is likely to be multiplied.

On the academic front, we are constantly updating us to keep track with the requirements of accreditation bodies and also with the global developmental trends. We are committed to enhance our competency through international student exchange programs, increased interface with companies and NGOs by way of student placement, faculty consultancies, and customize research programs. Industrial Visit



Altogether, 15 different courses were identified by the department to be offered to the students of 1st year of the Program of Marketing Management for the session starting from January 2020. Every student is supposed to complete 2 such courses during their stay at XISS.

Business analytics and data mining, Modeling using Supply Chain Analytics, Marketing Analytics, Entrepreneurship Essentials, Design Thinking, Block Chain Technology and Applications, Machine Learning, Managerial Skills for Interpersonal Dynamics, Finance for Non-Finance, Quantitative Marketing Research, Consumer Buying Behavior, Banking and Finance Markets etc were some of the courses which were identified by the Program to offer the same to the students keeping in mind the changing industry requirements. The courses received an overwhelming response from the students and all the students of 1st year of Program of Marketing Management registered and enrolled themselves in at least one of the courses offered.

TUTORIAL CLASSES

To improve the quality of teaching and learning in the department, tutorial classes were introduced from this year itself. This initiative was taken by the Institute by our Acting Director for all the programs. Some selected subjects were identified by the Head of Program in consultation with the Management and students were allotted to the different subjects based on their overall performances. The innovativeness of the program featured second year students acting as Tutors. The method involved in identifying the Tutor was through the process of self nomination followed by a Personal Interview by a Director nominated interview panel.





he placement cell of XISS is proud and elated to announce that the placement season 2019-20 has been truly remarkable and a landmark event. The feat we have achieved would not have been possible without the unwavering trust the corporate has shown in the quality and competitiveness of our students despite a generic slowdown in the overall employment scenario. It is a huge encouragement and humbling event and makes our resolve to serve the corporate with supply of capable and energetic talent stronger.

The final placement figure this year has already touched **88.59%** and with a good number of companies still lined up for the process we are set to soar higher still. As a testimony of competence and tenacity our students exhibited during their internship period we received **11 PPOs.** Highest CTC we clocked was another feather in the cap of the . Two students from PGDM-HRM received CTC of Rs **26.49 lacs;** highest ever. Stipend offered to summer interns was equally encouraging with the highest stipend of Rs **1.25 lac.**

All said, this is a success we must share the credit of with our regular recruiters who have shown enormous faith in our ability to provide the rich pool of talent we nurture at our . Participation of many new recruiters also excites us about working with fresh crops of corporations that are going to drive the future of employment generation. We thank both sets; regular and new recruiters, from the bottom of our grateful heart for the opportunity and we look forward to their continued patronage as we gear up to fulfill their expectations.

We have adopted a structured approach towards functioning of our placement cell wherein the Central Placement Cell (CPC) works in close coordination with departments through Department Placement Coordinators and Summer placement coordinators to guide all students through the journey of becoming a desirable talent. Mentoring, feedback from selected students, mock interviews and GDs etc are conducted across departments to prepare students for the upcoming placement

season. Timely preparation of placement brochures, identifying the fast evolving requirement of corporate and designing suitable training modules, enabling student placement representatives to connect and attract recruiters gives a self sustaining and a dynamic tinge to the entire placement effort.

We started the placement season on a very cautious note at a time when job losses and slowdown in the economy were the buzzwords. In this context getting the opportunity to host **122 companies** to participate in the process was not just a huge relief but highly motivating. Out of **122**, **35** were new recruiters. Total of **264 offers** were made with a highest CTC of Rs **26.49 lacs** per annum and the average CTC was **Rs. 5.85** per annum. The average salary for the HR department touched a record **Rs 8.61** lpa. The department of Finance management , Department of Rural management, the department of Marketing and the department of IT have achieved a placement of **96.43%**, **94.52%**, **89.09% and 83.33%** respectively.

The recruiters represented well diversified sectors such as consultancy, Automobile, power, Steel, Edu-tech, BFSI, IT, Retail, telecom, Pharma and Social/Non-profit organizations.

Highest number of job offers came from the Banking sector which recruited **10%**, followed by **Insurance** sector **9%**, and then **Development** sector **4%**.






Placement percentage 2018-20

The department has a project liaison cell that facilitates liaising with the clients, preparation of project proposals and expedition of recovery of pending dues from the clients. Mr. Ajit Tirkey is the in-charge of the cell and Mr. Nirmal K. Mishra provides regular technical support in e-tendering process. In the financial year 2019-20, the cell has applied 16 projects, out of which there are 4 projects related to social impact evaluation of activities done under corporate social responsibility, 4 projects related to evaluation of programs undertaken by the governments, 3 projects related to baseline studies, 3 projects related to end line studies and 1 each of the projects related to socio-economic survey and sanitation survey respectively. Besides, there are also 5 GIS projects applied in the financial year 2019-20.

4. Geographic Information System (GIS) and Remote Sensing (RS) Laboratory

The department has a GIS & RS laboratory established in the year 2015 that apart from taking up the projects related to GIS & RS also conducts a six month training programme on GIS & RS. Prof. Prakash C. Dash is the co-ordinator of the programme and in-charge of laboratory and Mr. Sunil P. Kumar is the laboratory assistant. In the year 2019-2020, training has been provided to the trainees in two batches; from March 2019 to September 2019 (6th batch) and from September 2019 to March 2020 (7th batch). The number of trainees who successfully completed the training in the 6th batch is 27 and in the 7th batch is 28. Out of the successful trainees in 6th batch, 7 of them sat for placement and all are placed in Ceinsys Tech Limited (Formerly ADCC Infocad Ltd.), Nagpur. Out of the successful trainees in 7th batch, 14 of them sat for placement and 12 are placed in different companies viz. 2 in Scanpoint Geomatics Limited, Ahmedabad, 3 in GIS Consortium India Pvt. Ltd., New Delhi and 7 in Computer Plus, Raipur.

Epilogue

Although the department has created a distinct space for itself among its clientele as a leading agency of carrying out consultancy assignments all over India, it is yet to establish itself in the academic circle in terms of substantial academic contributions. Thus, an environment needs to be created in the department where everyone will develop critical thinking, epistemological orientation, reading habit and writing skill thereby fulfilling the academic commitment along with consultancy assignments simultaneously. The department plans to organize an in-house orientation program

on application of statistics in social science research that will help all of us in the department for appropriate use of statistics in writing project reports as well as in writing research papers. A similar in-house training program on qualitative research will also be organized for better understanding of various qualitative techniques of data collection and data analysis beyond participatory rural appraisal. The GIS & RS laboratory is trying to explore the possibility of starting a diploma course on Geo-informatics as a lot of requests have been coming from the trainees for the same. If the technical requirements are met and the management provides a formal go ahead, then a final call in this regard

will be taken. The department has also an ambitious plan to set up NABL (National Accreditation Board for Testing and Calibration Laboratories) accredited Environmental Laboratory for air, water and soil quality assessment (Environmental Monitoring) and further seek accreditation from NABET (National Accreditation Board for Education and Training) for conducting Environmental Consultancy Services (Environmental Impact Assessment / Environmental Management Plan) in future. Dr. Amardip Singh has been recruited for this and he will lead this project.

Finally, I take this opportunity to extend my sincere gratitude to the Director and the Assistant Director for extending their constant support and sustained guidance. I express my heartfelt thanks to all my departmental colleagues who worked tirelessly and always stood by me for the whole year in running the department during the topsy-turvy conditions. Last but not the least I must acknowledge the hard work and perseverance put by our committed bunch of field investigators and data entry operators that made it possible for us to complete our tasks in time.

Department of Research and he Publication of XISS was established in June, 2002. The overall objective of the department is threefold: (i) to conduct research studies independently, (ii) to select quality research articles and publish those in academic journal JJDMS, and (iii) to organize seminars, talks and workshops in management fields. Since its establishment, the Department is continuously striving to move ahead in terms of its research growth and publications. During the academic year 2019-20, various activities undertaken and achievements that have been made by the Department are described below:

JJDMS continued to be in the UGC-approved list of Journals up to June 2019

In our last year annual report we have mentioned that the Standing Committee of UGC removed 4,305 journals from the list of approved journals in May 2018, because of poor quality/incorrect or insufficient information/false claims etc. However, Jharkhand Journal of Development and Management Studies continues to be in the UGC-approved list of journals with journal number 48435 under Social Sciences category up to June 2019.





Indexing of JJDMS in Indian Citation Index (ICI) Database

JJDMS got indexed in the ICI database. On 1st May 2019, Indian Citation Index released the approved list of the new journals and JJDMS included in their new list.

Publication of XISS Journal

In the year 2019, so far the following thematic/non-thematic issues have been published:

- (i) General Issue (January-March, 2019)

Book Review

Kalapura Jose and Vishal Ashutosh Kumar's book, "Dalit Education in Bihar - A Study of Exclusion", attempts to present an overview of the status of schooling in Bihar and India especially in the context of Dalits. By reading the book, Sudeep Kumar notes that the book shows a distinct pattern of inequality in terms of school admission and dropout among Dalits in the line of gender and caste. The authors have made an important contribution in understanding the programs and policies of both the union and the state government, especially Bihar, in improving the education status of Dalits. The reviewer of the book feels that the book has not been written very well. Nonetheless, the book covers an important subject of topical nature, the book is recommended to policy makers, planners, administrators and NGOs.

Another book "Interrogative Social Capital: The Jharkhand Experience" written by Prasad, A (2019) attempts to present a rare study and exploratory report on Government of Jharkhand's effort on the issue of "CPR Social Capital" and Church inspired development of tribal in India, especially

in Jharkhand. By reviewing the book, Rev. T.S.C Hans pointed out that while discussing evolution of Jharkhand policies on Environment the author has elaborated on Environmental composition of Jharkhand. Moreover, Common Property Resources (CPRs) and Social Capital thus comes under review through Jharkhand's common lands and forests, wild life, national park and other projects. The author has also provided 10 case studies of change on the ground level with interesting stories in social, economic and environmental effects. Thus, both the Government of Jharkhand and the Christian

inspired organizations are providing a set of potential solutions to some of the most severe problems facing Jharkhand today. The reviewer of the book feels that the strength of the book lies in its thoroughly scientific temperament. Although the numerous names and quotations might be burdensome to the minds of those not trained in Sociological fields, yet the style in which it is penned down makes it interesting. However, the reviewer also feels that the book can serve as a Hand Book for those who are seeking to serve the poorest to the poor.

Presently our Institute library has varieties of collection in print and digital forms including books, journals, magazines, newspapers, CDs, DVDs, online resources like e-books, journals, magazines and business cases etc. All these resources give the value addition in teaching, learning and research.

Primary objectives and planning

Our primary objective is quality collection developments in print, digital resources and databases with the latest available technology to identify and support the curriculum and to meet the changing information needs of the campus community.

DEVELOPMENT RESOURCE CENTRE (DRC)

Dr. Sant Kr. Prasad *Head of Department*

RC, as its name suggests is a Resource Centre and has been playing a crucial part since its inception by supporting various developmental initiatives undertaken by small NGOs and CBOs across Jharkhand. DRC under the aegis of Xavier Institute of Social Service (XISS) has been following the mission of serving the society and thus has been implementing several projects for improving the lives of villagers.

During the year 2019-20, DRC completed the project Enhancement of Livelihood Opportunities in the selected blocks of the south eastern region of Chotanagpur in the state of Jharkhand. The project was supported by CONFERENZA EPISCOPALE ITALIANA. After completion of the project duration DRC, XISS organized a project completion cum experience sharing workshop on 4th April 2019 at XISS, Ranchi. The basic purpose of this workshop was to share its learning, achievement and challenges under the Project titled, "Enhancement of Livelihood Opportunities in the selected blocks of south eastern region of Chotanagpur in the state of Jharkhand''. The project with the networking support of 11partner VOs/CBO started in the month of April 2012 with a major objective of "Enhancing Rural Livelihood" in the 10-blocks of 4-districts namely Ranchi, Khunti, Simdega and Gumla.


In their presentation the partner organizations stated that 56% tribal and marginalized were involved in different Income Generating Activities (IGAs). Keeping the achievement in mind, a comparative analysis stated that old VOs and CBOs (like GJJM, Hoffmann, JUS, CBO-Sarvada, Sahabhagi Vikas, DMVK) had shown their substantial achievements ranging from 50-70% of target groups involved in IGAs. In the case of VOs & CBOs (SRI, SITARA and CBOs- Namkum & Angara) their achievements were in the range of 15-30% target groups involved in IGAs. Since these VOs & CBOs were undertaken during the first year of extension phase so the total no. of target groups(in comparison to previous

year 2014-15) decreased but the achievement in terms of percentage is equivalent or even greater than the previous year (i.e. from 47% to 50%).

After the completion of the project duration, the partner organizations aimed for better avenues of income generating activities. Thus, activities like lac cultivation which had supported these partner organizations in the past with good economic support, were started again but with an aim of sustaining well in future as they have moved on to more income generating activities. Vegetable cultivation has been found as the most attracting activity amongst all, where



minimum capital is required to earn maximum return. Some parts of Ranchi and Khunti districts have been observed as vegetable export zones by the State Government which adds on volume to this income generating activity shift. The project observed a major shift in the nature of IGAs. VOs like GJJM, HSSS and JUS which had more focus on vegetable cultivation rather than Semialata Lac cultivation and Piggery, which was reported earlier. Similarly Sahbhagi Vikas's primary focus was on Piggery and Goatery Activities. During the reporting period target groups with the support from SHGs were facilitated to continue their IGAs.

Lastly the Partner Organization reached to a consensus that they need regular hand holding support from DRC and they will continue with the ongoing various IGAs initiated under of livelihood project and focus on:

- 1. Mainstreaming with JSLPS and other line departments for wider linkages.
- 2. Continuation of Training and Visit program and monitoring of SHGs and Income Generating Activities by DRC.
- 3. Facilitate SHGs to formulate Micro Credit Plan for those target groups who couldn't get IGAs in spite of linkages.
- 4. Attending SHGs-meeting and motivating them to get linkages and help them to select livelihood options and help them to start IGAs.
- 5. Monitor the growth and development of IGAs which has been started by target groups.

II. Proposed Program of DRC, XISS, Ranchi:

DRC, XISS, Ranchi has submitted a "Proposal on Watershed Development" to National Bank for Agriculture and Rural Development (NABARD),Regional Branch, Ranchi. The operational area will be Murhu Block of district Khunti in Jharkhand.

Under the proposed site there are 18-revenue villages (consisting altogether 28-hamlets/tolas) situated in the radius of 2-kilometer. These Villages fall under 3-panchyats namely Indipiri (6 villages 8 tolas), Kewra (11-Villages 21-tolas) and Headguan (1-Village 2 tolas). This project aims towards the livelihood up-gradation by focusing on food security of people. Hence, it will have an impact on 1250 households and touch the lives of around 7300 population of the proposed site.

- 1. DRC, XISS has submitted a Project proposal titled "Tejaswini: Socio-Economic Empowerment of Adolescent Girls and Young Women in Jharkhand." The project is sponsored by the Government of Jharkhand with the support of the World Bank. The Project aims to improve completion of market-driven Skills Training and Secondary Education for Adolescent Girls and Young Women (AGYW) in10 districts of Jharkhand. These districts are divided in zonal cluster which are as follows:
- Cluster -I (Palamu, Chatra and Koderma).
- Cluster -II (Latehar, Lohardaga and Khunti).
- Cluster -III (SarikelaKharsawan, Simdega and East Singhbhum).

The Project is being implemented by the Department of Women, Child Development and Social Security (DWCDSS), Government of Jharkhand through its autonomous body, Jharkhand Women Development Society (JWDS).

DRC, XISS is in the process of developing an ambitious Project Proposal titled "Youth Leadership and Development". The program aims to contribute towards integrated community development through youth leadership and their organizations to access entitlements and government programs. This project is to be facilitated in 4-districts (namely Ranchi, Khunti, Gumla and Simdega) of Jharkhand covering 2-2 blocks in each district.

INTRODUCTION

n XISS, the journey of promotion of entrepreneurship that started 46 years ago has still not reached its destination. In early 70s, the success of Entrepreneurship programs led XISS established a separate department as "Department of Entrepreneurship Development Programs", EDP in 1974. A long way still has to cover, precisely in a situation when economic liberalization & Global concept of business has adversely affected the Small scale industries & small business sector.

The result of the first few Entrepreneurship Development Programs inspired XISS to continue Entrepreneurship Development as one of its major activities. In 1974, the Institute created a new department named EDP department, to reinforce the efforts of entrepreneurship promotion.

Unemployment is the major challenge India has been facing in the process of its development. Lakhs of youths are entering the job market every year after completing their school/college education. This



tremendous waste of human resources and mismatch of potentiality with productive deployment has baffled the planners and administrators. All these indicate the need of promoting self-employment entrepreneurial ventures among the unemployed youths. We hope that the unemployed youths will take advantage of the department to develop entrepreneurship and set up their own enterprises.

Development of the department in all sense has always been given high priority by the Institute especially in recent years, such as, its own separate well equipped office, sufficient training rooms & class rooms with modern audio visual training aids, and a 30 bedded moderate hostel and good backup of full time faculties.

In order to maintain the effectiveness of the training programs are designed to meet the specific training requirements of the target group. The course content of the programs are continually revised to keep them in tune with the changing environment.

From the very beginning, stress has always been given to all-round development of entrepreneurship, such as, organizing Entrepreneurship Awareness Camps, different types of EDPs, Faculty Development Programs on Entrepreneurship, Management Development Programs, Capacity building of SHG members & their associates, Micro Enterprise Development, Research and Development, Publication, organizing Trainer's Training Programs, consultancy services, organizing seminars, workshops, trainer's meet, etc. as well as working as resource unit for other EDP related Institutions, skill development training programs for groups.

Consequently, emphasis on some of the activities has been given by us are as follows:

- To organize all types of Entrepreneurship Development Programs (EDPs).
- Capacity building for SHG members.
- Small Industries Management Program (SIMAP) and & short term Management Development Programs (MDPs) for different target groups.
- Research and Publication in the field of Entrepreneurship.
- Organizing Faculty Development Programs (FDPs) and Trainer's Training Programs (TTPs).
- Provide consultancy services to existing entrepreneurs for their further development, expansion.
- Organize Awareness Camps, Seminars, Workshops, Trainer's meet, etc.
- Working as a resource unit for other EDP related Institutions.
- Conduct Skill Development Training programs for groups.
- Assist Small & Medium Enterprises (SMEs) by organizing customized training programs for their Human Resource Development, or by providing specific consultancy.

Faculty Development Program (FDP) on Entrepreneurship:

Department has successfully completed the Faculty Development Program (FDP) on Entrepreneurship. The program aimed to equip the participants with knowledge and skills that were essential for inculcating entrepreneurial values in students and guiding and motivating their progress towards entrepreneurial career. The participants were Faculty members of University, Engineering



Institutes, Polytechnics, and Management Institutions and from Non Government Organization. Participants attended the program so that they can act as resource persons in the field of Entrepreneurship. They may float related courses, training programs and workshops in their respective institutions. The program was sponsored by, National Science and Technology Entrepreneurship Development Board, Department Science of and Technology,



Government of India, in association with Entrepreneurship Development Institute of India. We also planned to conduct more Faculty Development Programs (FDPs) on Entrepreneurship during the forthcoming financial year (2020-2021).

Entrepreneurship Awareness Camp (EAC):

With a view to expose students of academic institutions, offering degree/diploma courses in Science and Technology, to entrepreneurship as an alternative career, Entrepreneurship Awareness Camps (EACs) were conducted for students of Five different Universities, Polytechnics and ITIs at their premises:

- 2. Jharkhand Rai University, Kamre Ranchi.
- 3. Government Polytechnic, Ranchi.
- 4. RANTEC. ITI, Hehal, Ranchi
- 5. Department of Management, VBU Hazaribag.

CHILDLINE stands for a friendly 'didi' or a sympathetic 'bhaiya' who is always there for vulnerable children 24 hours of the day, 365 days of the year.

phone number that spells hope for millions of children across India, CHILDLINE is India's first 24-hour, free, emergency phone service for children in need of aid and assistance. Whether you are a concerned adult or a child you can dial 1098, the toll free to access our services.

We not only respond to the emergency needs of children like medical aid, repatriation, rescue, emotional support, and guidance etc. but also link them to services for their longterm care and rehabilitation in the space of shelter.

CHILDLINE is a platform bringing together the Ministry of Women and Child Development (MWCD), Government of India, Department of Telecommunications, street and community youth, non-profit organizations, academic institutions, the corporate sector and concerned individuals.





The CHILDLINE scheme across India is supported by the Union Ministry of Women and Child Development (MWCD) and facilitated by Childline India Foundation (CIF), Mumbai under the Integrated Child Protection Scheme (ICPS).

At City level intervention

As a phone number that spells hope for millions of children, any call coming into a CHILDLINE center is attended to by the CHILDLINE teams. This ensures that the calls coming in are attended to, all 24 hours at the phone-receiving center. Depending on the nature of the call, be it by a child or an adult, the team member responds to it effectively and it could be by going to meet with the child first and then linking him or her to medical help, shelter, repatriation, rescue from abuse or even intensive counseling as per requirement.

At CHILDLINE we believe that every call is important:

CHILDLINE Ranchi has been functional since December 2001. It is working as an Urban Model in Ranchi City with one Nodal organization, one Collaborative organization and one Support organization. The CHILDLINE team in Ranchi is directly covering 55 wards of Ranchi Municipal Corporation. Besides this team also received cases from distant blocks area like Silli, Mandar, Itki, Burmu, Ormanjhi, Kanke, Namkum, Tamar, Lapung and Bero., a Child Help Desk (Railway CHILDLINE) is also operation in Ranchi Station since June 2015. Presently, the following three partner organizations are implementing 1098 service in the district and at Ranchi Railway Station-

During the period, April 2019 till February 2020, CHILDLINE, Ranchi has intervened a total number of 129 cases of child protection issue, which includes cases like Child Labour, Child Marriage, Sexual Abuse, Physical and Emotional abuse, Child trafficking, Corporal punishment, Beggary etc. CHILDLINE Ranchi has intervened a total number of 497 cases till date including all categories. Railway CHILDLINE, at Ranchi and Hatia Railway Station has intervened 402 cases from April, 2019 till February 2020.




Figure 1: Showing CHILDLINE, Ranchi case intervention in 2019-20

CHILDLINE, Ranchi covers various events and activities across the town and have been able to restore, reunite lost and runaway children with their families. We are constantly learning from each other's diverse experiences. CHILDLINE, Ranchi reaches to the most marginalized children with the



objective of providing them rehabilitation and care from unsafe situations. Any child in distress or in crisis is calling to toll- free 1098.

Following are the activities organized during the period April, 2019 till February, 2020 by CHILDLINE, Ranchi.

A one day training program on Juvenile Justice Act 2015 and Protection of Children from Sexual Offences (POCSO) Act 2012 was organized with teachers' of Government Middle School, Ranchi district on 25th February 2020 at XISS (Nodal organization of CHILDLINE, Ranchi). Teachers from 30schools were attended the training program. This one day training program was beneficial to the teachers and they came to know in detail about Child in Need of Care and Protection (CNCP) and Children in Conflict with Law (CCL). Resource persons of this training program were Ms. Reshma Singh, Head, Jharkhand Association for Advocacy and Legal Initiatives (AALI) and Ms Bhawna Kumar, Member, Juvenile Justice Board (JJB), Ranchi.

- The CHILDLINE Advisory Board (CAB) meeting of this financial year was organized in the office of DDC, Ranchi on 24th February, 2020. Following decisions taken were :
 - CHILDLINE has to attend a crime meeting of Police department (CID).
 - Regular training of School teachers' and Police officials on child rights and child protection issues
 - Formation of Rescue team in Ranchi district
 - Regular coordination meeting with allied (Education, Police, Health, Labour etc.) system.
- The Resource Organization meeting was organized on 27th September 2019 in the conference hall of XISS. Following suggestions were taken care off:
 - Substance abuse
 - Child beggary
 - Dropout children
 - Health care of children
- On the occasion of World Day against Child Labour, a signature campaign and drawing competition was organized in community hall of Bero Block in which fifty children were participated from twenty five schools of Bero Block on 12th June 2019.
- CHILDLINE Se Dosti is a week-long campaign organized from 14th 20th November 2019 to make ordinary citizens a stakeholders of CHILDLINE 1098. The primary objective of this campaign is to spread awareness amongst those who remain unaware of the work was done by CHILDLINE and generate CHILDLINE 'Dosts' everywhere. Be it an allied system, a student, an auto driver, a rickshaw puller or a housewife, it is our objective to reach out to people from different walks of life to get to know CHILDLINE, begin to care about vulnerable children and initiate action towards change. The ostensible purpose of this campaign is to generate a Million 'Dosts' for CHILDLINE and acquaint people with Child Rights and Protection.
- CHILDLINE received a grant of the current financial year 2019-20 vide sanction letter no. BG/ E/19-20/26/SI dated 27th December 2019.



OPEN HOUSE Program

Children are also involved in evaluating the CHILDLINE service through Open House programs. It is a platform for children to express their opinions, give suggestions, address conflicts and give feedback. Open House serves as a means for children to assess, review and evaluate CHILDLINE. This open uninhibited interaction allows the CHILDLINE team along with the children to identify solutions to problems. Thus giving children the authority to judge a situation and decide a verdict or determine a course of action in relation to a problem. It also

serves as an opportunity to share the positive encounters between children and functionaries of allied systems like the police, health personnel etc, who otherwise traditionally share a relationship of mistrust. This helps not only in giving insights for improving the service but also in building a relationship of trust with the children.

During the period April, 2019 till February, 2020, CHILDLINE Ranchi has conducted 24 Open House and 06 special awareness activities. CHILDLINE has also ensured participation of Principals, School teachers, Students, Ward members, Civil society, SHGs members and other stakeholders in said programs through formal invitation.

Outreach and awareness

CHILDLINE's success is measured not just by the number of calls in a city / district but also by the levels of awareness. CHILDLINE awareness strategies aim at empowering children to dial 1098 when in crisis, building partnerships across society where each one has a role to play in protecting children and advocating for children. CHILDLINE team has conducted 8967person hours of outreach and awareness program from April 2019 till February 2020. It includes daily outreach activities, engagement with Blocks, Panchayats, Communities, Parents groups, CHILDLINE Children's group, conducting special events etc. Around 72% of the cases intervened by the team has been received from outreach.
